

E.N. BISSO CANAVERAL, INC.

Port Canaveral – Rate Schedule

Services provided by E.N. Bisso Canaveral, Inc. ("E.N. Bisso") at Port Canaveral shall be at the following rates and subject to E.N. Bisso's standard [Terms & Conditions](#) incorporated by reference (hereafter referred as "Terms") as in effect at the time the Services are performed.

Effective February 1, 2025

DOCKING OR UNDOCKING CHARGES PER TUG - FIRST TWO USED

GROSS TONNAGE	BASE RATES
20,000 & Lower	\$3,400.00
20,001 – 25,000	\$3,900.00
25,001 – 30,000	\$4,400.00
30,001 & Higher	\$4,900.00

GROSS TONNAGE CHARGE PER TUG

Vessels 30,001 GRT or greater shall be charged the base rate of \$4,900.00 plus \$155.00 per every 1,000 GRTs over the 30,000 GRT threshold.

Base Rates provided above are not subject to discount unless under term contract.

Vessels requiring use of spare tug stationed at the port to be charged at above rates plus an additional 100% premium assessed on applicable rates and GRT charges.

Barges with tugs secured in the notch shall be charged Base Rates. Barges with tugs not secured in the notch and all others will be charged at 150% of Base Rates.

Barges and Ships without power shall be charged at 150% of Base Rates.

SHIFTING (Undocking then immediate Docking) shall be charged at 150% of Base Rates.

HOURLY RATES

For tugs providing hourly service or whenever specific rates are not provided in this Rate Schedule, a rate of \$1,575.00 per Tug per hour will apply. The hourly rate shall commence upon the Tug leaving its station or last job and shall terminate upon the Tug returning to its station or alongside its next job. Hourly rates are rounded up to the next half-hour, with a minimum charge of two (2) hours, and are not subject to discount.

ADDITIONAL TIME

Base rates above include allotted time of up to one and one-half (1.5) hours for Dockings, Undockings and Shifts. When jobs exceed one and one-half (1.5) hours, there will be an additional charge of \$1,575 per Tug per hour, rounded up to the next half-hour.

STAND-BY CHARGE

When a tug is ordered to Stand-By for a Docking/Undocking/Shift without assisting the vessel, the charge will be 75% of the applicable Base Rates.

WAITING TIME

An hourly charge of \$1,035.00 per hour per tug is applicable when vessels do not Undock/Shift within a half-hour of the Reporting Time. Minimum one hour, rounded up to next half-hour.

CANCELLATION

If an order is cancelled after a Tug is dispatched, the hourly rate shall apply from the time the Tug leaves its station or completes its previous job until it returns to its station or reports to another job, with a minimum charge of one (1) hour, rounded up to the next half-hour.

OVERTIME CHARGE

For Services performed between the hours of 16:00 and 08:00 on weekdays, and for Services performed during any hour on holidays, Saturdays, or Sundays, a 35% additional charge will apply to base rates and hourly rates referred to in this Rate Schedule. If the holiday falls on a Saturday or Sunday, overtime rates will apply on the Friday prior to or the Monday following the holiday. Recognized holidays are New Year's Day, Martin Luther King, Jr. Day, Presidents' Day, Good Friday, Memorial Day, Juneteenth, Independence Day, Labor Day, Veterans' Day, Thanksgiving Day, and Christmas Day.

JETTIES CHARGE

Vessels requiring tugs to proceed beyond the harbor entrance jetty breakwater shall be charged an additional \$1,050.00 per tug. If tugs are required to be beyond the entrance jetties for periods greater than one hour, an additional charge of \$1,575.00 per tug per hour will apply, rounded up to the next half-hour.

EXCLUDED SERVICES

This Rate Schedule and the Terms shall not apply to rescue towing, assisting Vessels aground or otherwise in peril, salvage, any other services not specified in this Rate Schedule, and any operations whatsoever beyond the sea buoy. Such excluded services are subject to separate rates and terms and conditions to be mutually agreed by the parties.

FUEL SURCHARGE

A Fuel Surcharge may be assessed on all rates and is not subject to discount.

ORDER TIMES

Three (3) Hours' notice is requested for first two tugs.
Seventy-Two (72) Hours' notice is required for third/spare tug.

LOA SURCHARGE

Any vessel exceeding 750 feet LOA (Length Overall) shall be charged an additional \$15.00 per foot per tug.

PAYMENT TERMS

Payment is required within 30 calendar days of invoice date unless otherwise agreed. After 30 days, if unpaid then discounts are no longer valid, and invoices are deemed to be overdue. Overdue amounts will be charged interest at the rate of 1.5% per month backdated to the invoice date. In the event an overdue invoice is placed in the hands of an attorney for collection, the vessel to which service has been rendered or the responsible party shall pay all expenses for collection, including reasonable legal fees and court costs at the rate of 25% of the gross undiscounted invoice as well as all interest due until fully paid.
